

### **GENERAL TERMS AND CONDITIONS**

#### PART I - INTRODUCTION

1. Subject of these General Terms and Conditions (hereinafter, referred to as: "GTC") is to define the rights and obligations of the European Society of Gynaecological Oncology, with the seat at c/o Kenes International, rue François-Versonnex 7, P. O. BOX 6053, CH-1207 Genève, Switzerland, registration number: CHE-113.573.524 (hereinafter referred to as "ESGO"), an association for experts in the field of gynaecological oncology and an individual applying for ESGO membership, registering to ESGO courses and to ESGO annual congress (as defined below) of the association.

### PART II - MEMEBERSHIP

# **ESGO** offers following types for membership:

REGULAR MEMBERS - individuals residing in Europe and Israel

- Professionals from high-income countries €180
- Professionals from upper-middle-income countries: Group A €75

## Establishment and termination of the membership

- 1. Membership starts by completing a registration form at <a href="www.esgo.org">www.esgo.org</a> and payment of the membership fee.
- 2. Membership and membership rights are limited only to the individual member and cannot be transferred to any other third person or legal successor of the member.
- 3. Membership is terminated by the end of a calendar year.
- 4. Complaints or request for membership cancellation can be done by contacting ESGO at membership@esgo.org.

### MEMBERSHIP FEE, PAYMENT CONDITIONS

- 1. Membership fee needs to be paid by a member according to the current membership fee rates for given year (hereinafter referred to as "membership fee").
- 2. Accounting period for the membership fee is one calendar year, the membership fee can be paid 3 months before the beginning of the calendar year and any time during the calendar year.
- 12. Membership fees can be paid by bank transfer to the bank account of ESGO, by PayPal, by credit card or in cash payment (only possible onsite of ESGO congress).

# Part III - REGISTRATION TO COURSES

- 1. Each course organized by the ESGO has its own website and separate registration.
- 2. Application to courses can be done at <a href="https://www.esgo.org/esgo-courses/">https://www.esgo.org/esgo-courses/</a>
- 3. Fee for individual courses and well as cancellation conditions are unique to each course and are clearly stated at the courses' webpage.

### PART IV – REGISTRATION TO ANNUAL CONGRESS

- 1. Annual congress is organized by the ESGO, has its own website and separate registration.
- 2. Registration for the congress can be done at https://congress.esgo.org/registration/
- 3. Fee for individual categories as well as cancellation conditions are clearly stated at the congress webpage and differ every year.

### PART V - FINAL PROVISIONS

1. The member or course/congress participant is obliged to inform ESGO about any change of personal or contact information submitted at registration without unnecessary delay.



- 2. ESGO will be sending all information to its members and courses/congress participants electronically to the email address submitted at registration.
- 3. ESGO processes member's and courses/congress participants' personal data provided in the registration form to be able to fulfil all legal obligations or to send its members promotional emails, or for any other purpose to which the members have given their consent. Data processing follows the European Parliament regulation no. 2016/679 from 27<sup>th</sup> April 2016 on individual data protection and in compliance with ESGO Privacy Policy, that states how ESGO handles the personal data, what information is stored, how the information is used and defines any third parties that may process the data. ESGO Privacy Policy also defines all members' rights in connection to data processing, especially the right to be informed, corrected, deleted or the right to any time withdraw the consent.
- 6. ESGO has the right to change these GTC anytime. Should the change take place, ESGO is obliged to publish the information about the change of GTC (including the new suggested version) on the website <a href="https://www.esgo.org">www.esgo.org</a> 30 days before the planned change.
- b. Should the member or course/congress participants agree with the new version or does not inform ESGO otherwise, it is considered as approval of the new version.

VOP changes become valid on the first day of a month following the approval.

- 7. Current and updated version of GTC can always be found on www.esgo.org.
- 8. Should any part of these GTC become invalid or inefficient, this will not influence any other parts of the GTC.
- 9. In any matter that are not defined in these GTC, all rights and obligations of both sides are governed by the legal regulations of Switzerland.
- 11. These GTC become effective and valid on 1st March 2021.
